## MEMORANDUM OF UNDERSTANDING

(For Scientific and Educational Co-operation)

This Memorandum of Understanding (hereinafter referred to as MOU) is made on the 3<sup>rd</sup> day of September 2019

BETWEEN

ICMR- Regional Medical Research Centre, Gorakhpur, whose address is Baba Raghav Das (BRD) Medical College Campus, Gorakhpur, Uttar Pradesh PIN-273013 India (hereinafter referred to as "ICMR-RMRCGKP").

AND

Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur whose address is Civil Lines, Gorakhpur (U.P.) - 273009 India (hereinafter referred to as "DDUGU").

## **Whereas**

- A. ICMR-RMRCGKP and DDUGU wish to develop academic exchanges and cooperation in teaching and research in furtherance of the advancement and dissemination of learning.
- B. ICMR-RMRCGKP and DDUGU to co-operate to promote, facilitate and implement co-operation in the following programs and activities.

## **Now it is hereby agreed as follows**

### **General**

1. ICMR-RMRCGKP scientist may participate in the teaching program in the area of Biotechnology, Microbiology, Biochemistry, Zoology, Pharmacy, Botany, Environmental Sciences etc. of DDUGU on request and subject to mutual convenience.
2. ICMR-RMRCGKP scientists and faculty members of Departments of Biotechnology, Botany, Zoology, Pharmacy, Botany, Environmental Sciences etc. of DDUGU will work towards joint projects thereby mutually using leading research facilities developed and to be developed at ICMR-RMRCGKP and DDUGU.
3. A student working at ICMR-RMRC-GKP can be registered for Ph.D. degree at DDU Gorakhpur University provided he qualifies RET and is eligible for Ph.D. registration as per the Ph.D. ordinance of the university. In that case, a faculty member of the department, in which the student is registered, will be the supervisor and the concerned scientist from ICMR-RMRCGKP will be the co-supervisor. In all cases, Ph.D. ordinance of the university will be applicable as and when required.
4. The faculty and students of the above-mentioned departments of DDUGU shall be allowed to use library of ICMR-RMRCGKP subject to prior permission of the Director. Scientists and Ph.D. students of ICMR-RMRCGKP shall likewise be given the library facilities at DDUGU with prior permission of competent authority.

## **Academic and Development Programmes**

1. For the mutual benefits of the two institutions i.e. ICMR-Regional Medical Research Centre Gorakhpur and Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur there will be exchange of ICMR-RMRCGKP scientist and faculty members of mentioned departments of DDUGU.
2. ICMR-RMRCGKP and DDUGU scientists/faculty members will help each other in preparing common research programmes.
3. While registering ICMR-RMRCGKP students for Ph.D. degree in DDUGU, the ordinance related to Ph.D. degree of DDUGU will be applicable. The students/researchers of ICMR-RMRCGKP shall be required to qualify the entrance examination for the registration of Ph. D. as per norms of DDUGU, Gorakhpur.
4. ICMR-RMRCGKP and DDUGU will work closely to generate appropriately trained manpower in the related areas through organization of formal academic curricula, symposia and other capacity building programmes.
5. The student registered for Ph. D. at DDUGU will have to complete and qualify Pre-Ph.D. course work conducted in the university. The scientists of RMRC will also actively participate in Pre-Ph. D. course work.
6. Honorarium, TA/DA (if applicable) will be provided to the faculty members/scientists/technical staff of DDUGU and ICMR-RMRCGKP.
7. Authorship of the papers will be decided by the respective guide/co-guide of the ICMR-RMRCGKP and concerned departments of the DDUGU after mutual understanding.
8. Fellowship monitoring will be decided by the competent authority on the basis of activation of the fellowship (if candidates activate their fellowship from ICMR-RMRCGKP then it is maintained by ICMR-RMRCGKP and if activated in above mentioned departments of DDUGU then University will maintain the fellowship).



9. Any issue of IPR or patent originating as a result of mutual collaborative research work between DDUGU and ICMR-RMRCGKP, will be shared by both the parties after mutual understanding.


### Duration of MOU

1. This MOU shall be valid for a period of 60 months from the signing. The duration may be extended with the consent of both the parties under mutually agreed terms and conditions.
2. It is further agreed that the Vice-Chancellor, DDUGU, Gorakhpur and Director-ICMR-RMRCGKP through periodic meetings will monitor the progress of this MOU. Any change or modification/termination as introduced/suggested by the review committee (comprising of Vice-Chancellor, DDUGU and Director ICMR-RMRCGKP) will be binding to both the organizations.
